MISSION IN ACTION

Highlights from 2015

- Our 2015 Annual Support Campaign, under the leadership of Kevin Cowser, Pam Norton, and Rick Routhier, enabled us to provide the equivalent of nearly \$300,000 in financial assistance, ensuring that no one is ever turned away from maintaining a healthy lifestyle at the Y.
- Our 19th annual golf outing at the Country Club of Fairfield, chaired by Chris Pohle and Rick Selvala raised over \$80,000 to support our Special Needs department.
- 2015 marked our third year offering the LIVESTRONG at the YMCA cancer wellness program. This 12-week program is available to any cancer survivor within our community at no cost.
- Throughout the year, over 2,000 individuals came together with their families to enjoy fun, special events such as Family Dinner Night, the Y's Family Mud Run, our Halloween Party, and our annual family circus.
- Our special needs department continues to work to ensure everybody feels welcome at our Y. In 2015, over 100 individuals with special needs participated in programs and events at the Y. Thanks to funds raised through our Annual Support Campaign and the annual charity golf outing, support staff is offered to these individuals at no additional cost.
- In 2015, the Y partnered with Stamford Health to improve the health and well-being of our community through an on-site Wellness Nurse Coordinator and physical therapy.
- Over 1,600 kids developed skills, focus, and self-confidence while participating in our youth recreational basketball league or competing on our competitive swimming, diving, or synchronized swimming teams.
- In 2015, over 150 families looked to the Y's full-day childcare, preschool, and after-school childcare programs to provide a safe and nurturing environment for their children.
- The Y is committed to helping our members and the community maintain a healthy lifestyle. People of all ages are improving their well-being through the programs and resources at the Y.
- 2015 featured our ninth year in partnership with Facing the Future, a child development facility in Kibera, Kenya. With the help of generous donors, we are able to provide school supplies and two meals a day to approximately 300 children in need. Last year, Facing the Future grew to serve eighth grade and achieved a near 100 percent student passing rate of the Kenya high school entrance exam, with nearly one half the students achieving "elite scores".

FOR YOUTH DEVELOPMENT

Nurturing the potential of every child and teen

We believe that all kids deserve the opportunity to discover who they are and what they can achieve under the guidance of adults who care about them.

In 2015:

- Over 150 families belong to the Y's childcare community. Through full-day childcare/preschool and after-school childcare programs, the Y creates a safe and nurturing place for children to learn, discover, and grow.
- Over 120 children participated in the Y's school vacation camp program, which provides a fun childcare option for families on school vacation days.
- Nearly 600 children grew and made friends and lasting memories at summer camp. Over 40 campers were children with special needs, making our camps an inclusive and enriching experience for all.
- In 2015, 165 pre-teens, teens, and young adults developed leadership skills and received one of their first work experiences at our summer camps. Whether a camp counselor or counselor-in-training, all became role models.
- In 2015, nearly 725 children learned to become safer and more confident in the water through swim lessons.
- Through the Y's recreational sports programs and leagues, approximately 1,500 children developed a love for sports, while building a sense of confidence and teamwork.
- The Y continues to serve as a place for fun and safe out-of-school activity for middle schoolers and teens through activities like Middle School Madness, open gym, archery, sports clinics, and more.
- Over 450 young athletes participated in the Y's three competitive aquatics teams including swimming, diving, and synchronized swimming, developing goal setting, leadership, time management, and self-confidence.
- In 2015, the Y launched a partnership with Parisi Speed School. Approximately 120 kids ages 7 and older participated in its first year at the Y, enjoying a positive training experience that improves speed of movement and strength in character regardless of ability.





The New Canaan YMCA is the proud host for Girls on the Run Fairfield County, a program for girls ages 8-13 that encourages self-respect and healthy living. in 2015, Girls on the Run served over 400 girls in 14 school districts throughout Fairfield County.

FOR HEALTHY LIVING

Improving the nation's health and well-being

With a mission centered on balance, the Y brings families closer together, encourages good health, fosters connections through fitness, sports, fun, and shared interests.

In 2015:

- The Y continues to serve as a community resource dedicated to promoting wellness and disease prevention among people of all ages and abilities. From cardio and strength building classes, to mind-body and nutrition programs, everybody is welcome at the Y as they work toward maintaining a healthy lifestyle.
- 850 seniors in our community come to the Y to stay active, healthy, and connected.
- Throughout the year, over 2,000 individuals and their families took a break from their busy schedules to enjoy time together at one of the Y's special events. The Y fosters family togetherness through community events like Family Dinner Night, the Halloween Party, and the annual family circus.
- In collaboration with Stamford Health, the Y hosted ten lectures, each providing information on a different health topic, empowering attendees with knowledge. These lectures were free and open to the entire community.
- Nearly 100 children participated in the Y's Families In Training (F.I.T.) program. Once completed, participants can workout at the Y with their parents, encouraging families to stay active and healthy together.
- For the second year, the Y has served as the home for a local Parkinsons Support Group, supporting over 80 individuals.
- Over 500 fathers and children strengthened their relationship and made lasting memories through the Y Guide and Princess program in 2015.
- In 2015, the Y partnered with Stamford Health to help support the health and well-being needs of our community through the introduction of an on-site Wellness Nurse Coordinator and physical therapy services.





In 2015, the Y ran three LIVESTRONG at the YMCA programs, serving 20 community members who are cancer survivors. This program is available to any cancer survivor at no cost.

FOR SOCIAL RESPONSIBILITY

Giving back and providing support to our neighbors

Since 1954, we have been listening and responding to the needs of our community through education, training, motivation or support. Whether it's building a healthier community at home, or reaching across borders through our World Service Initiative, we are there to help others.

In 2015:

- Through donations to the Y's Annual Support Campaign, over \$300,000 in financial assistance was provided ensuring that no one is ever turned away from the youth development and healthy living resources at the Y.
- As a community partner, the Y works with many other community organizations including serving as the home pool for the New Canaan High School swimming and diving teams, a resource for New Canaan sports organizations, and a site for the New Canaan Public School's transition program.
- To help build a stronger community, the Y offers use of our facility at no charge to local non-profits including: South Avenue Cottage, ABC House, A-Home, Boy Scouts and Girl Scouts, and the Homeschool Cooperative.
- In 2015, 875 individuals volunteered over 15,000 hours at the Y, helping to provide services to the community, and engage in philanthropy.
- The Y's Togetherhood volunteer committee provides members the opportunity to give back to those in need. Togetherhood hosted four community projects in 2015, including a shoe drive, breakfast run to NYC, and serving meals at a nearby homeless shelter.
- The Y is proudly in our ninth year of partnership with Facing the Future, a child development center in the Kenyan slum of Kibera. Nearly 300 needy children currently attend the center receiving two meals a day, education, hygiene, and medical attention. Last year, Facing the Future grew to serve eighth grade and achieved a near 100 percent student passing rate of the Kenya high school entrance exam, with nearly one half the students achieving "elite scores".





The Y's special needs department continues to thrive as a community resource. Serving over 100 children, teens, and young adults with special needs and their families, the Y offered over 50 specialized programs in 2015, plus one-on-one support allowing children with special needs to participate in traditional Y programs at no additional cost.
